## Exhibitor Programs Terms And Conditions

1. In these Terms and Conditions the term "Exhibitor" means the signatory of the application and includes all employees or agents of such; "Package" means that described in the Exhibitor Programs brochure; "Contract" means the signed undertaking between the Exhibitor and the Organizer; "Exhibitor and/or Partner" means an organization accepted to participate in the Fair, or a potential Exhibitor and/or Partner; "Fair" means the Qatar Career Fair 2009; "The Organizer" means Qatar Foundation, Qatar Petroleum, Qatar University and the Ministry of Labour.
2. The Organizer will set a prescribed date which will be communicated in writing for the purpose of application for Exhibitors. This will be the only time period whereby such application will be permitted.
3. At the close of the prescribed application period, and in the event of a number of Exhibitors applied for a particular level, then the Organizer will select the Exhibitors on a first-come-first serve basis based on the date and time of the e-mail received.
4. Full payment must be made within two calendar weeks of the organization being advised officially in writing from the Organizer of their acceptance as an Exhibitor and/or Partner. If the Exhibitor and/or Partner does not make payment within the prescribed time, the Organizer reserves the right, after due notice to the Exhibitor and/or Partner, or their assigned agents, to cancel the application.
5. If the Exhibitor and/or Partner cancel the application, after the application is accepted by the Exhibitor and/or Partner and payment has been made to the Organizer, fifty percent of the monies paid will be forfeited.
6. Upon written acceptance by the Organizer of the Exhibitor's application, a contract shall arise between the Organizer and the Exhibitor with respect to these Terms and Conditions, subject to variations as mentioned. In case of non payment of any sum due or any breach or non observance of any of these Term and Conditions by the Exhibitor, the Organizer shall have the full right to revoke this contract and may remove and exclude the Exhibitor, without prejudice, and recover all monies payable, and the Organizer has the right to recover damages sustained from the Exhibitor.
7. The Organizer shall have full power to determine, in every respect, the allocation of space and it shall be entitled, for any reason which, in its sole opinion, is in the general interest of the Fair to vary the general layout or the allocation of any particular Exhibitor already allocated and the Exhibitor shall accept a new allocation of space in substitution of that originally allocated.
8. All display advertising, exhibits, partnership arrangements shall be appropriate to the subject matter of the Fair in the sole opinion of the Organizer and shall be tasteful and of a suitably high standard, and shall not contravene or conflict with any local law, moral or custom and, if in the opinion of the Organizer, the Exhibitor is in breach of this clause the Organizer may direct the Exhibitor to rectify such breach and the Exhibitor shall comply immediately.
9. Exhibitor Programs and Partnership Programs are to be paid in Qatari Riyals.
10. All Partnership Programs mentioned are exclusively open to Qatar Career Fair 2009 Exhibitors.
11. The Organizer reserves the right to alter, add to, or amend any of these Terms and Conditions and the decision of the Organizer shall be final. The Organizer agrees to communicate such alterations, additions or amendments.
12. The Organizer cannot accept any complaint or claim against it unless it is submitted in writing to the address given below within two weeks of the closing date of the Fair. All claims and disputes shall be settled in Doha in accordance with Qatar law and customs.
